 - Work in the Element 3 Health Program (good recruitment program) with AVA (asked a member to be the program lead)
 - AVA Club Development committee just released a number of ideas that we need to evaluate
 - Encourage more use of electronic delivery of materials vs. repro
 - Membership incentives (dues reduction recruitment policy?)
 - Changing accounting period to Calendar Year from current July-June year (AVA changed last year themselves)
 - Annual fiscal audit for 2020 fiscal year submitted to auditor last month
 - Bi-annual US Army "Private Organization" re-certification scheduled for Spring 2021

- Review membership fees (Other clubs are higher; ours have been \$10 for at least the last 13 years)
 - Some discussion ensured that indicated a \$12-\$15 annual dues should be considered
 - Club Vice President Jessica Ruit suggested that if a club member walks a certain number of walks, their membership dues might be reduced.
 - Highland Falls directions should be included in the West Point Walk Box in case West Point YRE is unable to be walked.
 - Joan Kimmel, former club officer, will continue to be the 2021 Walk Incentive Book program manager, and the 2021 booklet will be prepared
 - Again, thanks were offered to Mike Green, AVA Atlantic Region Director, for continuing to both host without cost and perform web master work for the club.
